IMPORTANT INFORMATION

The Carroll Bass Team is committed to conducting its recreational programs and activities in a safe manner and holds the safety of participants in high regard. The Carroll Bass Team continually strives to reduce risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is a risk of injury when choosing to participate in recreational programs/activities. You are solely responsible for determining if you are or your minor child/ward is physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way, or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK

Fishing is intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury. All hazards and dangers cannot be foreseen. The very nature of fishing is hazardous and risky. Inherent risks to fishing include, but are not limited to, hooking oneself or others with a fishing hook, bites from fish, wading or falling into the water and drowning, and self-inflicted wounds; possibly caused by improper fishing technique, carelessness of other fishermen, lack of proper protection, poorly selected and maintained equipment, horseplay, carelessness, inadequate supervision or instruction, and premises defects, among other reasons. In this regard, it is impossible for the Carroll Bass Team to guarantee absolute safety.
